

**Controlled Substance Order Form Requirements
Statutory Citations and State Agencies**

Jurisdiction: The State, District or Locality

Registering Authority: The entity with which manufacturers and distributors of controlled substances must register

Statutory Cite: The cite or cites to statutes/regulations related to controlled substance order forms

Defers to Federal Law: Registrants' compliance with federal order form requirements constitutes compliance with state law order from requirements
