New York	Requires all dispensers and dispensing practitioners to report	Veterinarians required to report
North Carolina	Requires all dispensers to report	Veterinarians not required to report
North Dakota	Requires all dispensers to report	Decision on whether veterinarians will be required to report is forthcoming
Ohio	Only requires pharmacies to report	Not applicable – only pharmacies required to report
Oklahoma	Requires all dispensers to report	Veterinarians required to report

Rhode Island	Requires all dispensers to report	Veterinarians required to report

Virginia	Specifically exempts dispensing of covered substances by veterinarians to animals	Veterinarians not required to report
Washington	Requires licensed health care practitioners with prescribing or dispensing authority to report	Veterinarians required to report
West Virginia	Requires all pharmacies and dispensing medical service providers to report	Awaiting confirmation from state officials on whether veterinarians are required to report
Wyoming	Only requires pharmacies to report	Not applicable – only pharmacies required to report

NOTES:

- *In states that only require pharmacies to report data to a prescription monitoring database, prescriptions written by veterinarians and subsequently filled in pharmacies may get reported.*
- *There are several states actively considering implementing PMP legislation – information regarding veterinary reporting requirements in these states will be incorporated into this chart as legislation is passed and the information becomes available.*
 - *Alaska SB 196 – Engrossed as of April 13, 2008 (bill only requires pharmacies to report)*
 - *Florida HB 1011 – Work-shopped in committee on March 14th, 2008 (bill requires pharmacies and dispensing practitioners to report)*
 - *Georgia HB 455 – Read and referred in Senate on February 27th, 2008 (bill requires all dispensers to report)*

VETERINARIAN REPORTING REQUIREMENTS UNDER STATE PRESCRIPTION MONITORING PROGRAMS

- *Kansas SB 491 – Enrolled and presented to the governor on April 11, 2008 (bill requires all dispensers to report; veterinarians specifically included in the bill's definition of dispenser)*
- *Mississippi SB 2713 – Sent to the governor on April 17th, 2008 (bill specifically includes dispensers of veterinary controlled substances in list of entities requires to report)*
- *Missouri SB 732 – Referred to House Crime Prevention & Public Safety Committee on April 17th, 2008; HB 1619 – Reported Do Pass April 17th, 2008 (bills specifically exclude veterinarians from list of those required to report)*
- *Washington HB 1553 – Reintroduced January 14th, 2008 (bill requires all dispensers to report)*
