Highlighted bills have passed and been signed by that state's governor.

## II. MEPHEDRONE

Mephedrone (4-methylmethcathinone) is a derivative of cathinone. It is currently only scheduled by Michigan (M.C.L.A. §333.7212) as “mephadrone” with the above stated chemical designation. Mephedrone is known by the trade or slang names of MCAT, 4-MMC, meow meow, bounce, bubbles, and mad cow. The following states have bills proposing to schedule mephedrone:

## **VI. GENERIC LANGUAGE**

The Advisory Council on the Misuse of Drugs (ACMD), a panel of experts tasked with advising the British government on the regulation and control of substances, has proposed a generic definition for the control of cathinones as follows:

Any compound (not being bupropion ... ) structurally derived from 2-amino-1-phenyl-1-propanone by modification in any of the following ways, that is to say,

- (i) by substitution in the phenyl ring to any extent with alkyl, alkoxy, alkylendioxy, haloalkyl or halide substituents, whether or not further substituted in the phenyl ring by one or more other univalent substituents;
- (ii) by substitution at the 3-position with an alkyl substituent;
- (iii) by substitution at the nitrogen atom with alkyl or dialkyl groups, or by inclusion of the nitrogen atom in a cyclic structure.

## VII. NAPHTHYL PYROVALERONE ANALOGS

The ACMD recently provided a report to the British government regarding the naphthyl pyrovalerone analogs of cathinone. Currently, there are three states in the United States that schedule any of the naphthyl pyrovalerone analogs, including naphyrone, or have any proposed legislation or bills to schedule these drugs. They are: Kentucky (2011 KY H.B. 121 proposes to schedule naphthylpyrovalerone); Michigan (2011 MI S.B. 259 proposes to schedule naphyrone and pyrovalerone; 2011 MI H.B. 4565 proposes to schedule naphyrone); and Texas (2011 TX H.B. 2118 and 2011 TX S.B. 1423 propose to schedule naphyrone, butylone, pentylone, eutylone, and ethylone plus others). The United States Congress is also proposing to schedule naphyrone, ethcathinone, ethylone and butylone (2011 Cong. US HR 1254).
