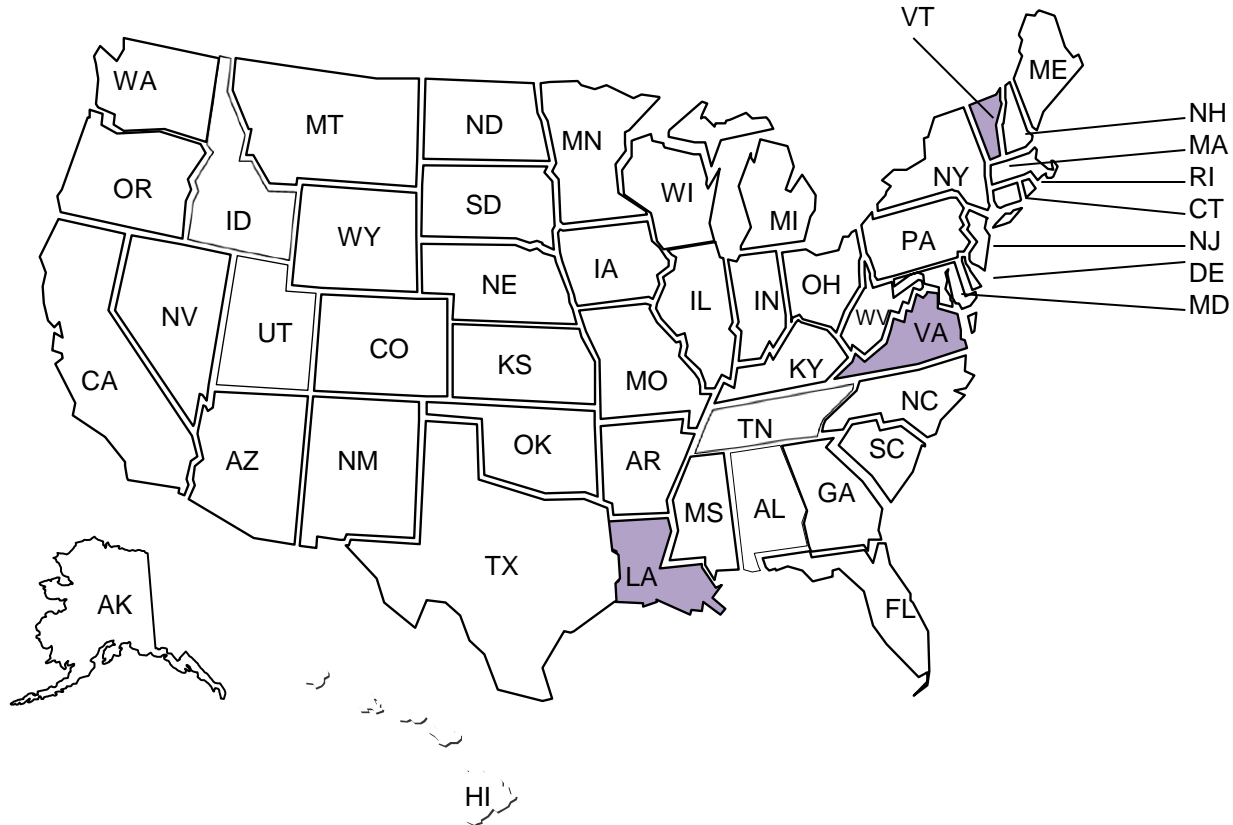




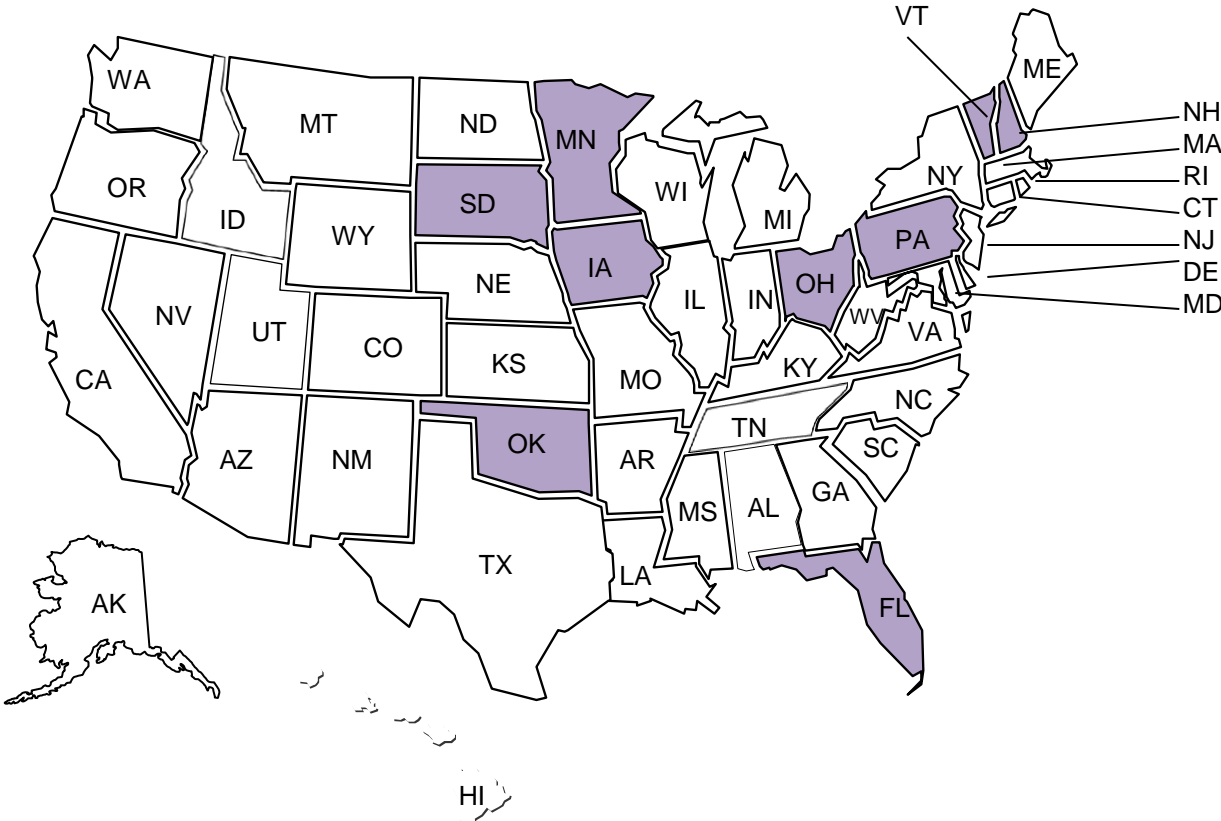

# States that Have Scheduled 25I-NBOMe by Statute or Regulation



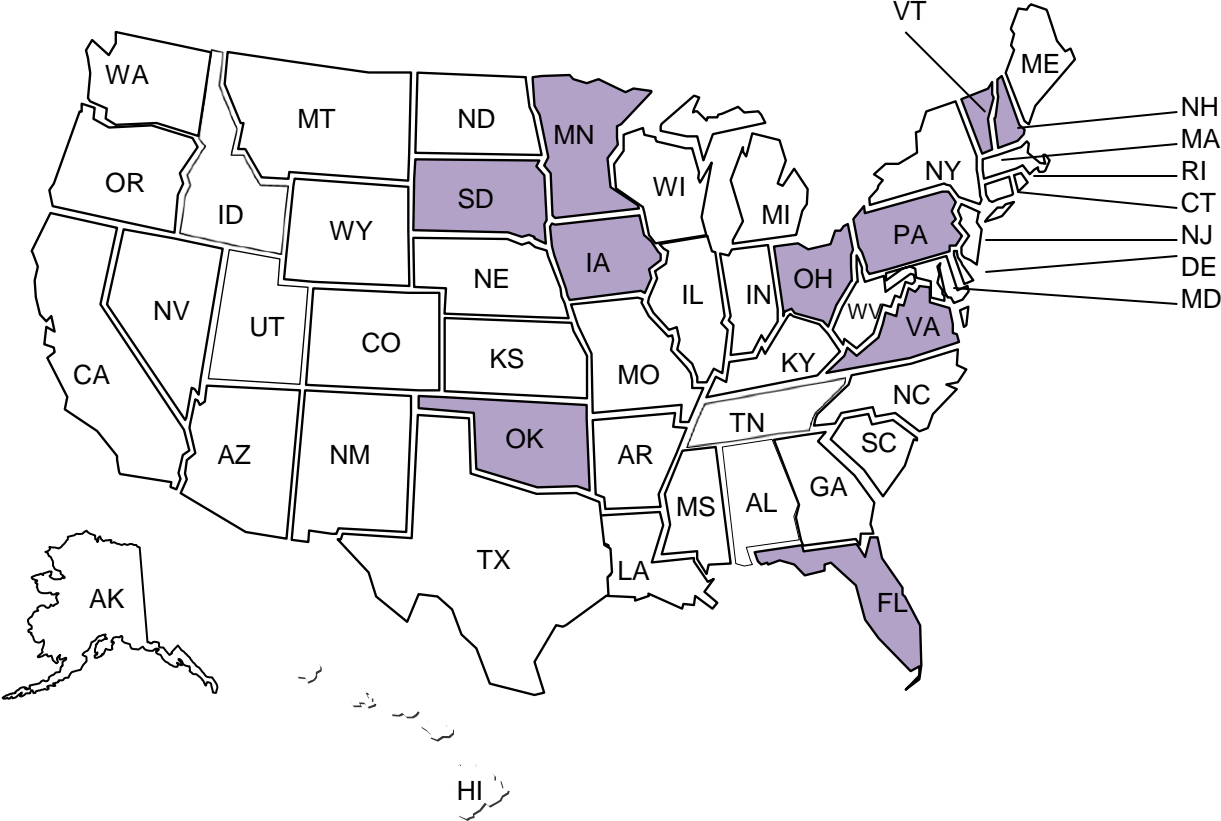

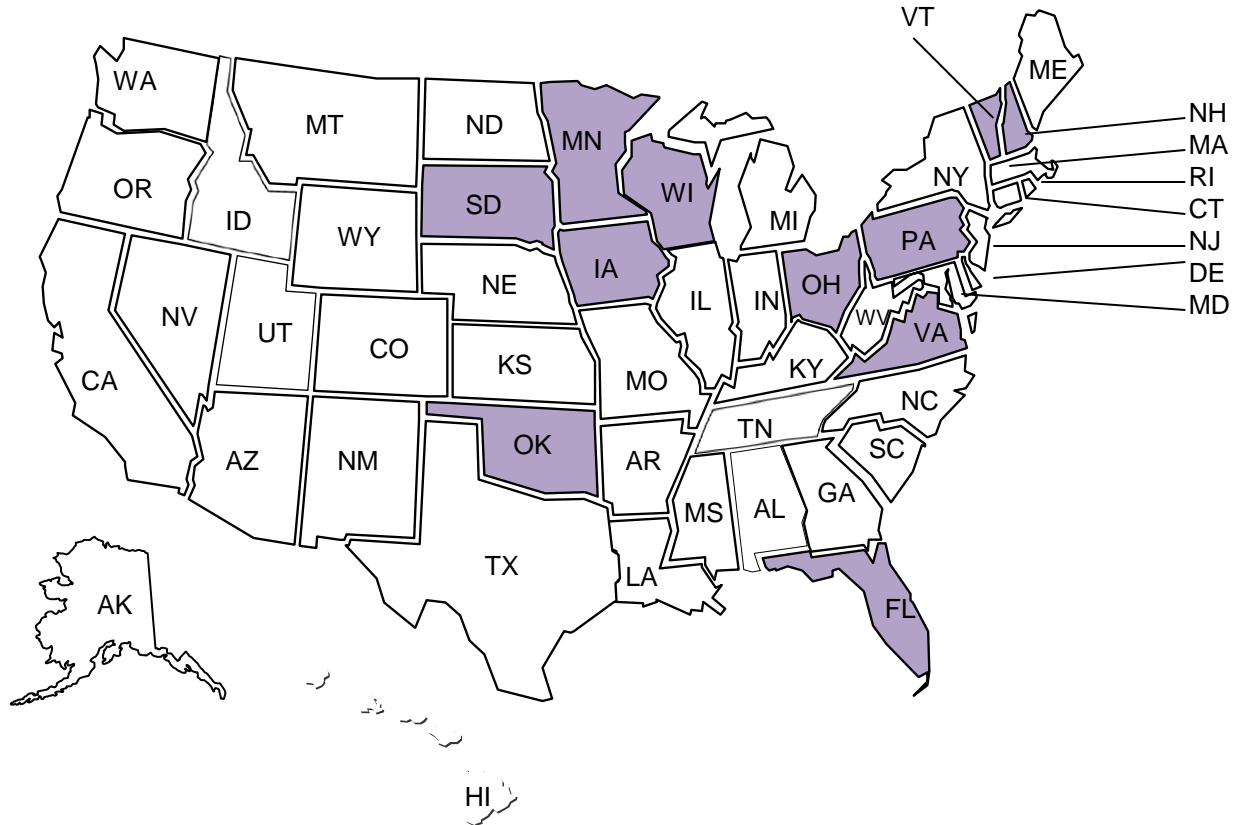
# States that Have Scheduled 2C-E by Statute or Regulation



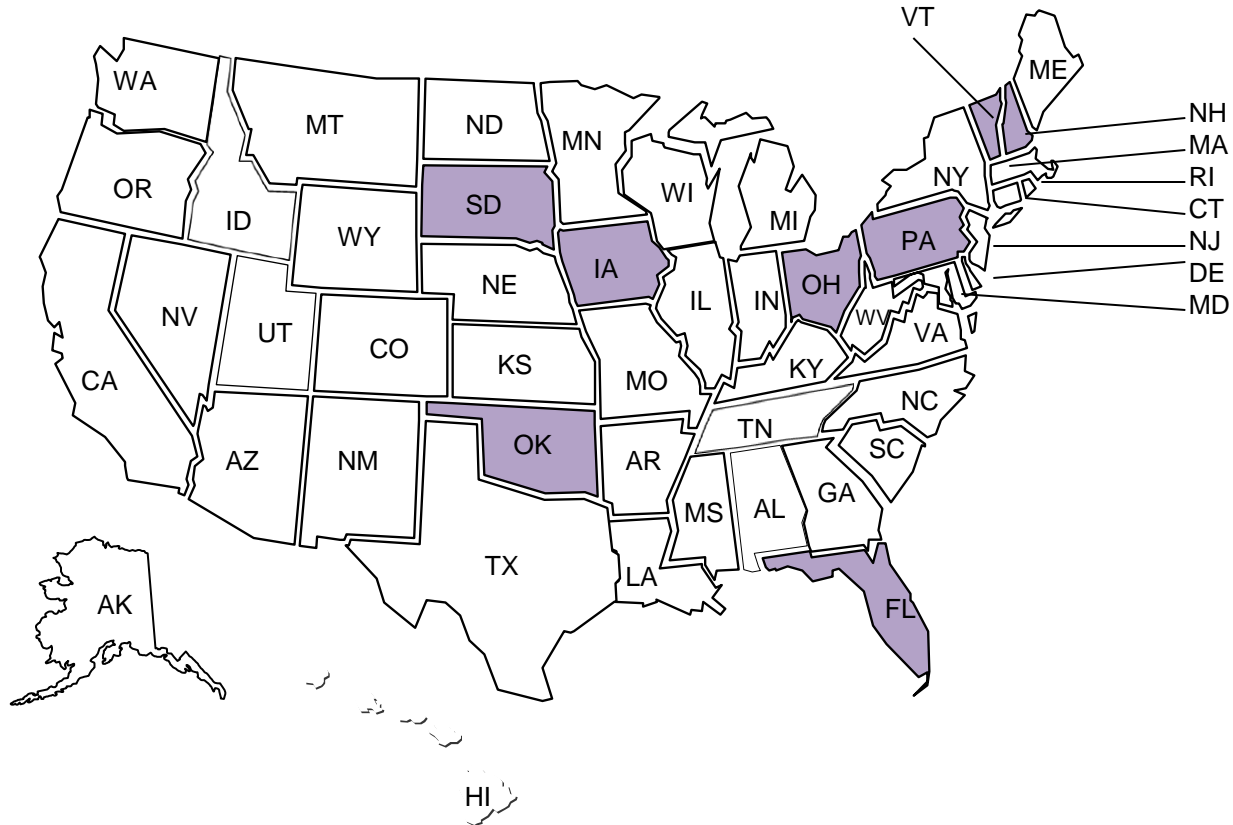

# States that Have Scheduled 2C-I by Statute or Regulation



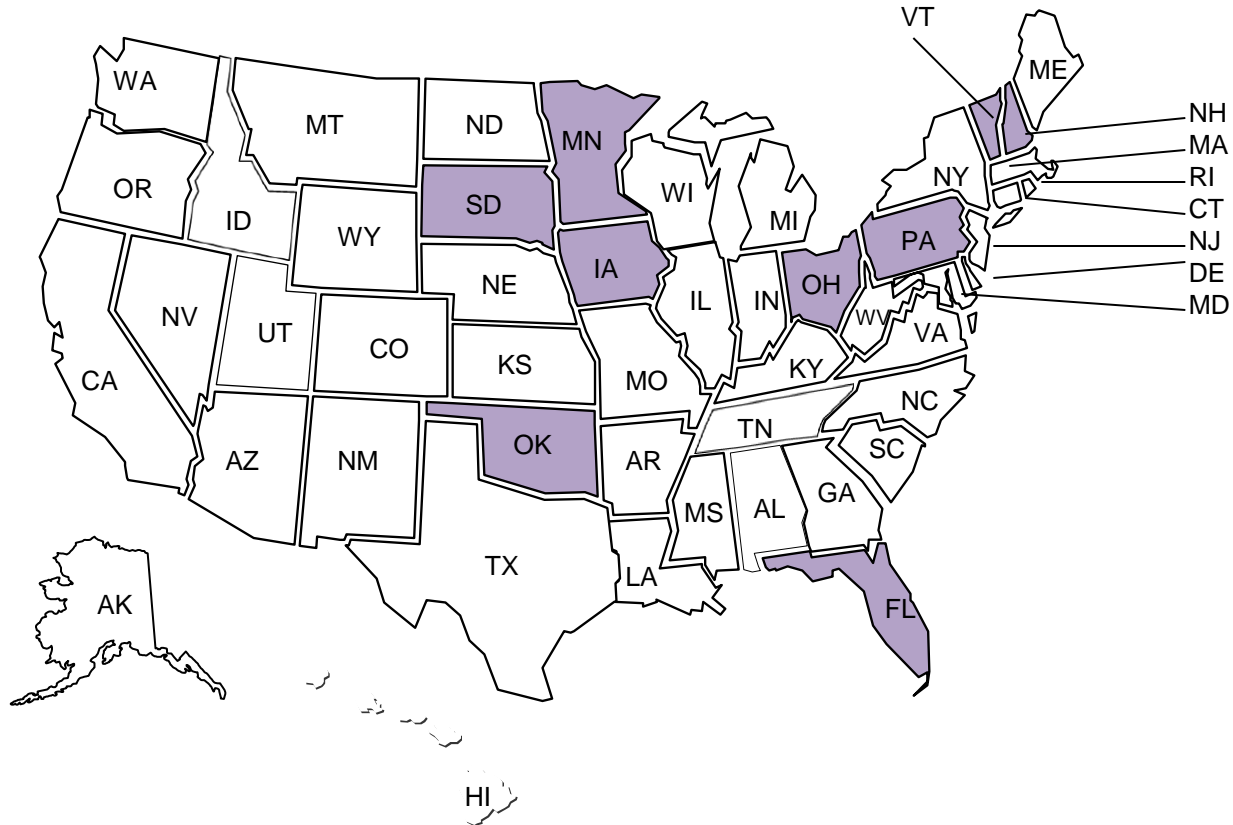
# States that Have Scheduled 2C-T-2 by Statute or Regulation

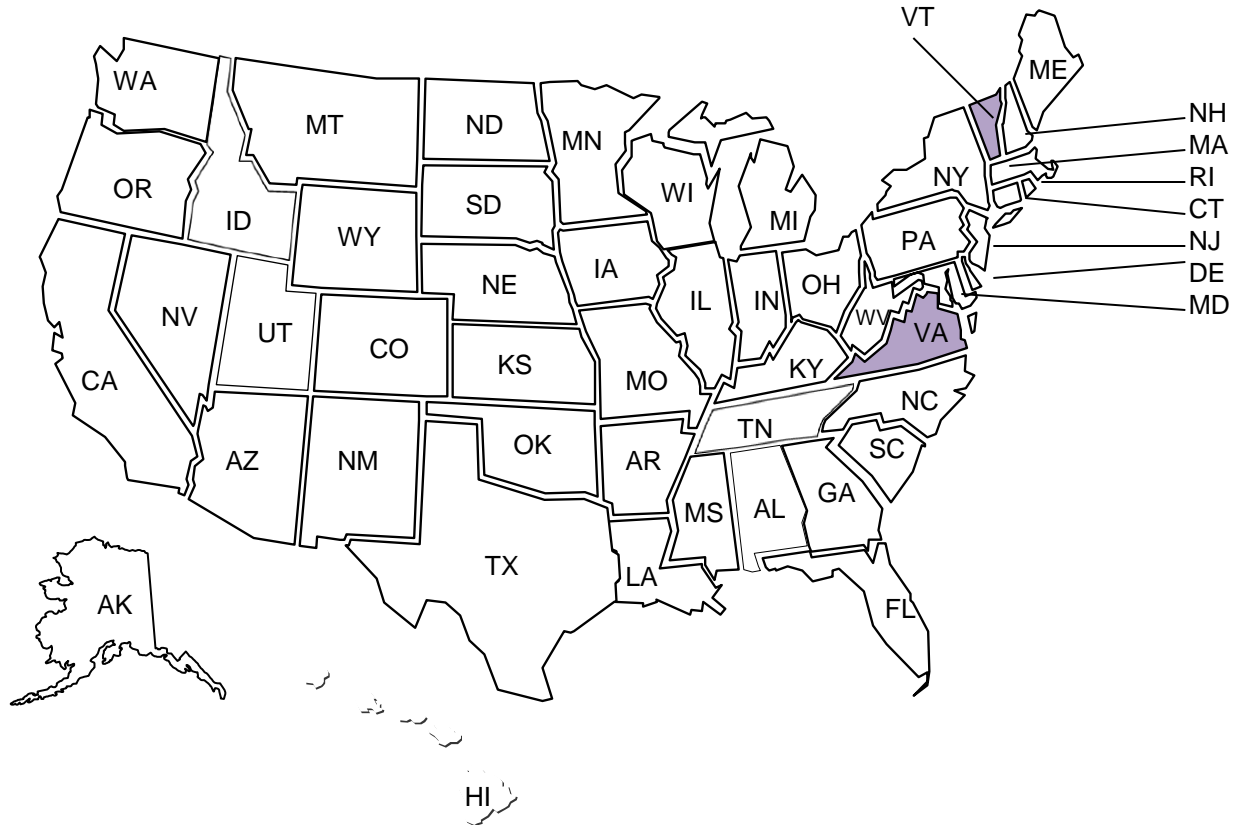
# States that Have Scheduled 2C-T-4 by Statute or Regulation







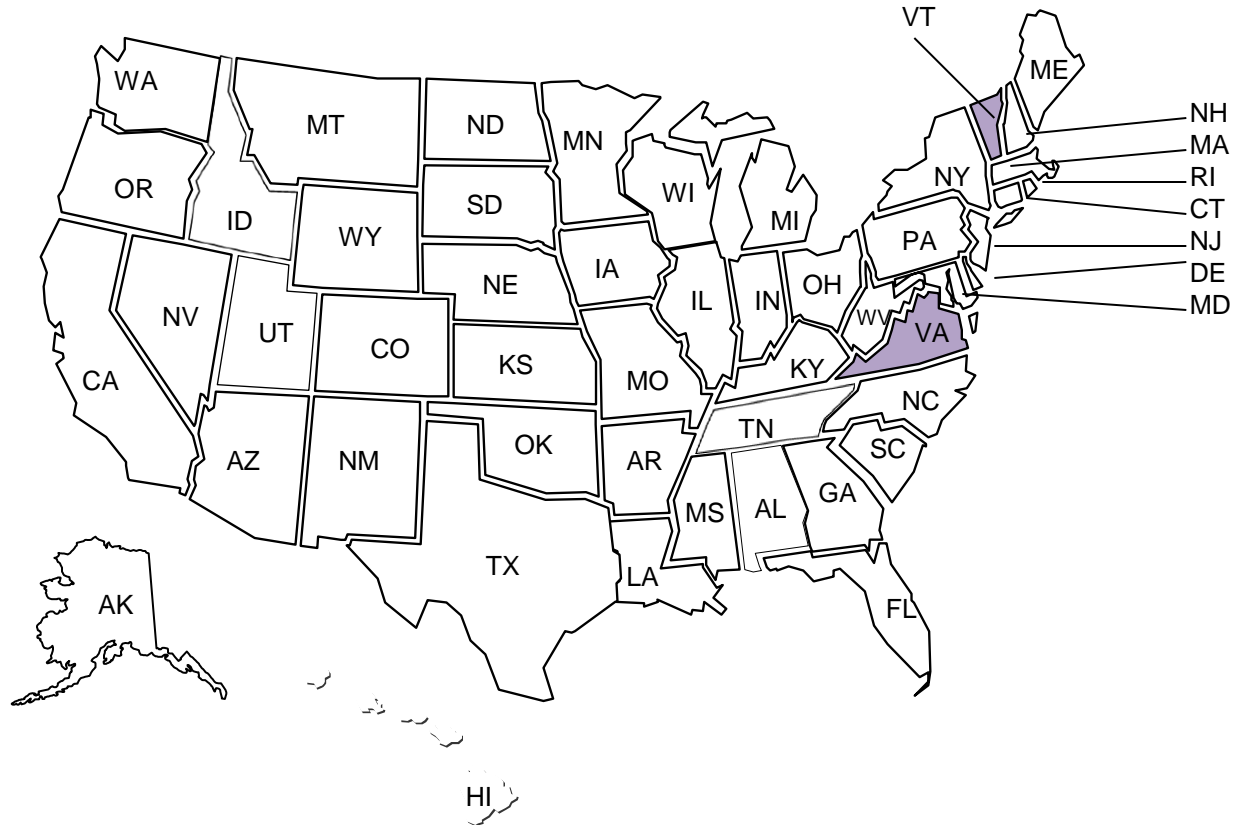
# States that Have Scheduled 4-FA by Statute or Regulation

# States that Have Scheduled 4-FMA by Statute or Regulation

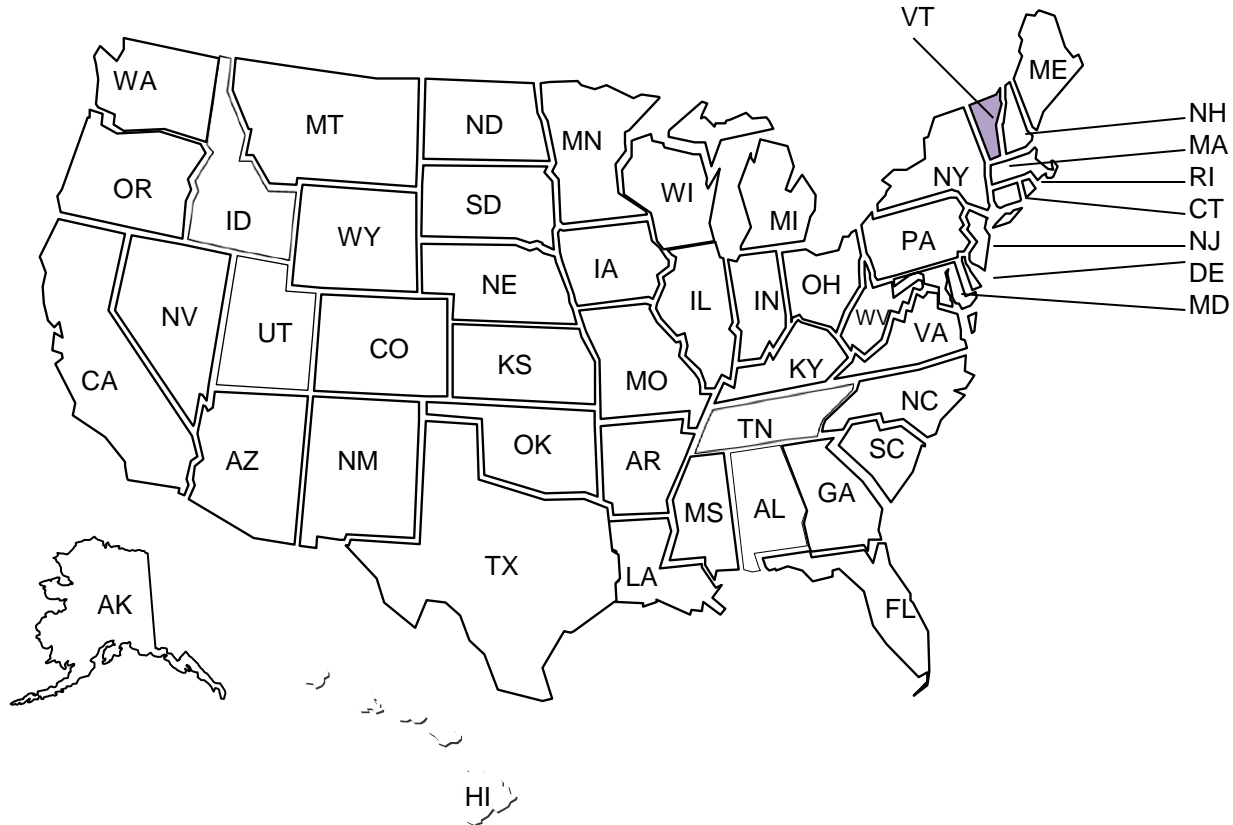

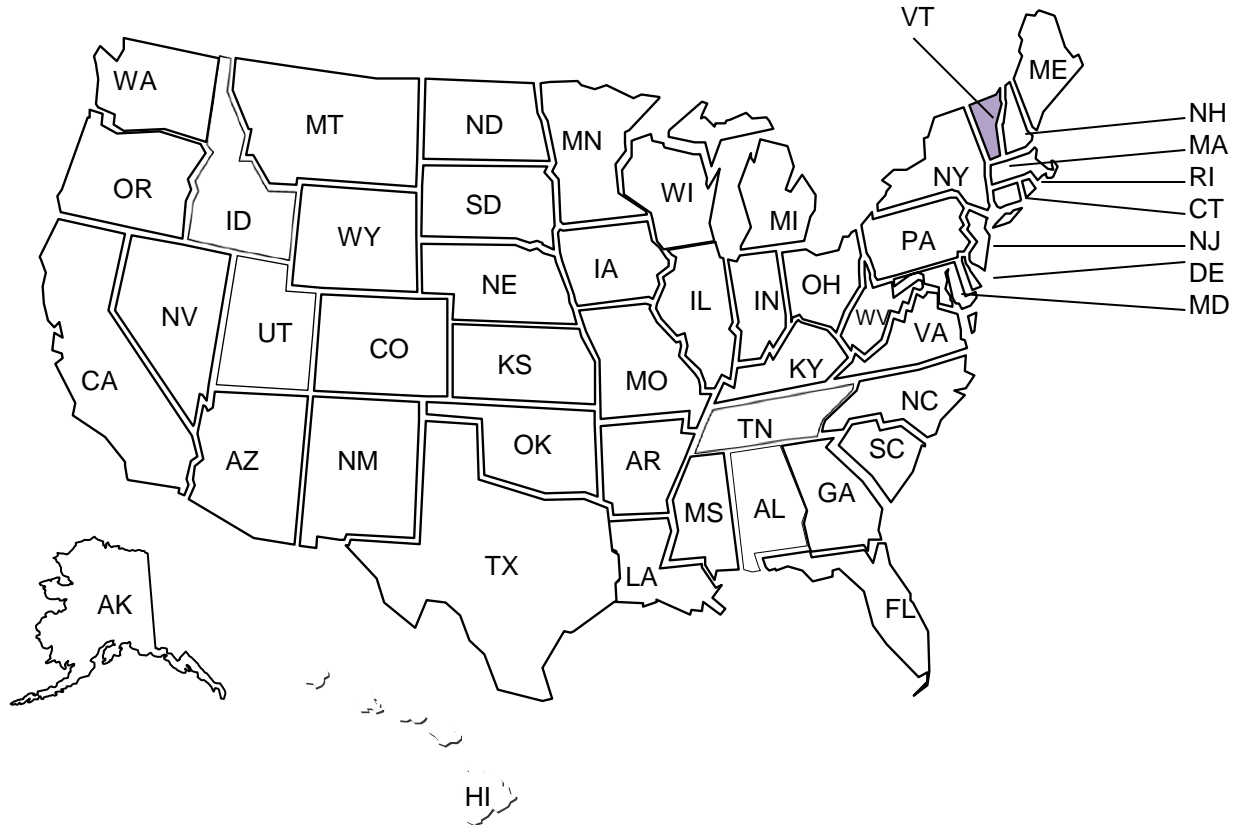
# States that Have Scheduled 4-MeO-PCP by Statute or Regulation

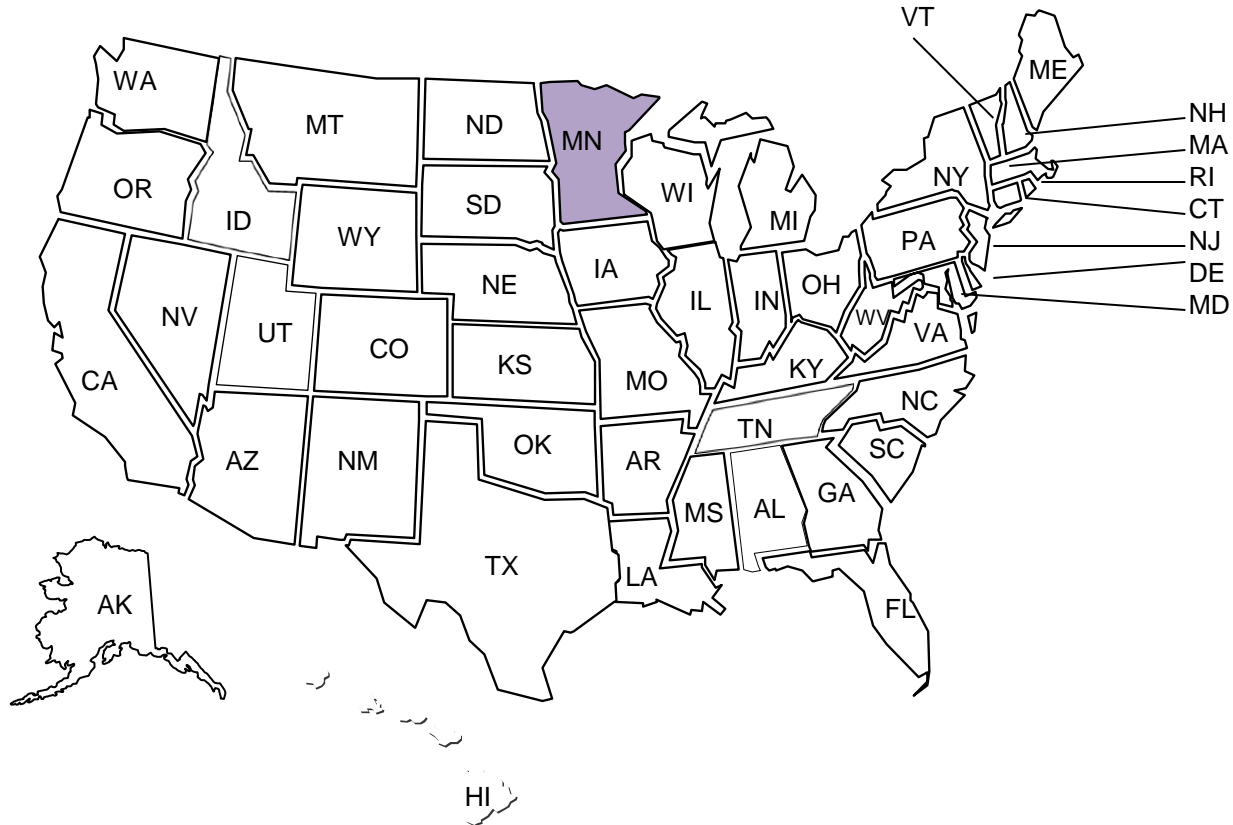
# States that Have Scheduled 4-methyl-aET by Statute or Regulation



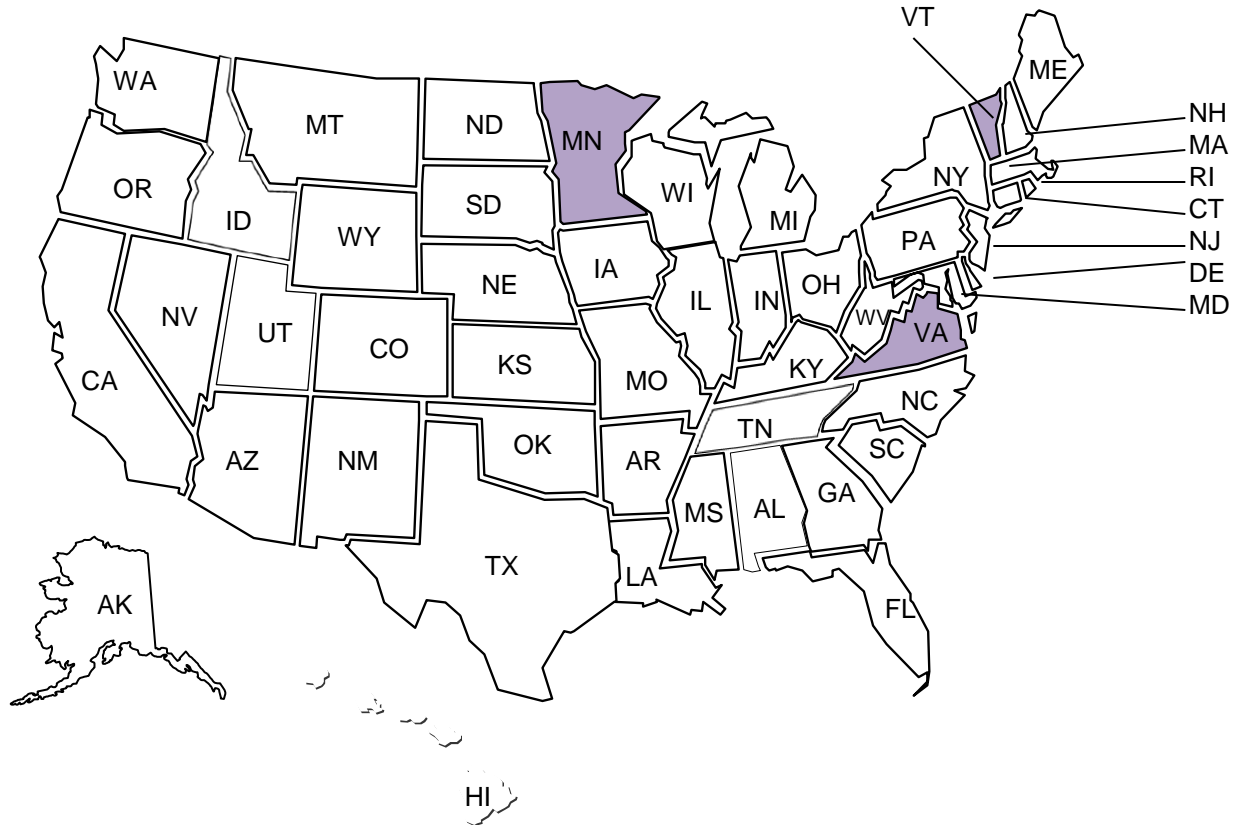

# States that Have Scheduled 5-MeO-DALT by Statute or Regulation



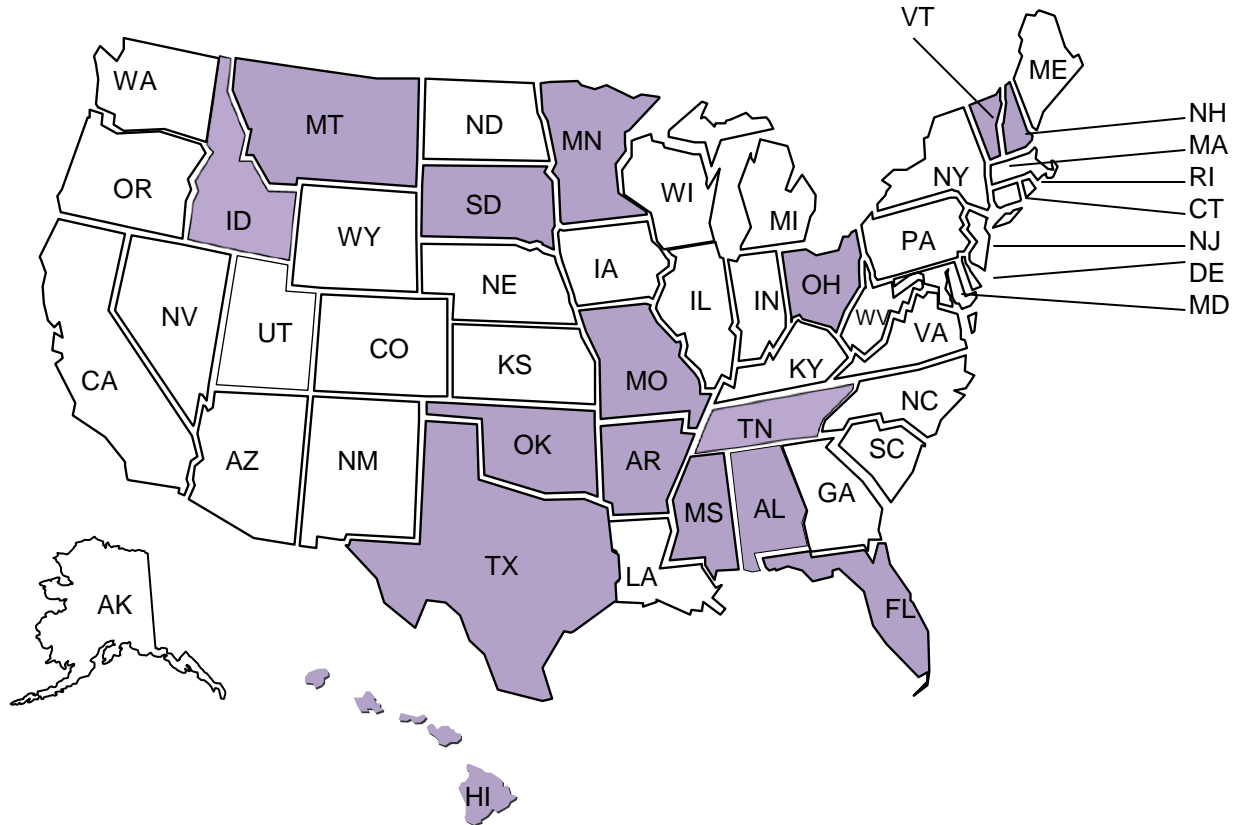

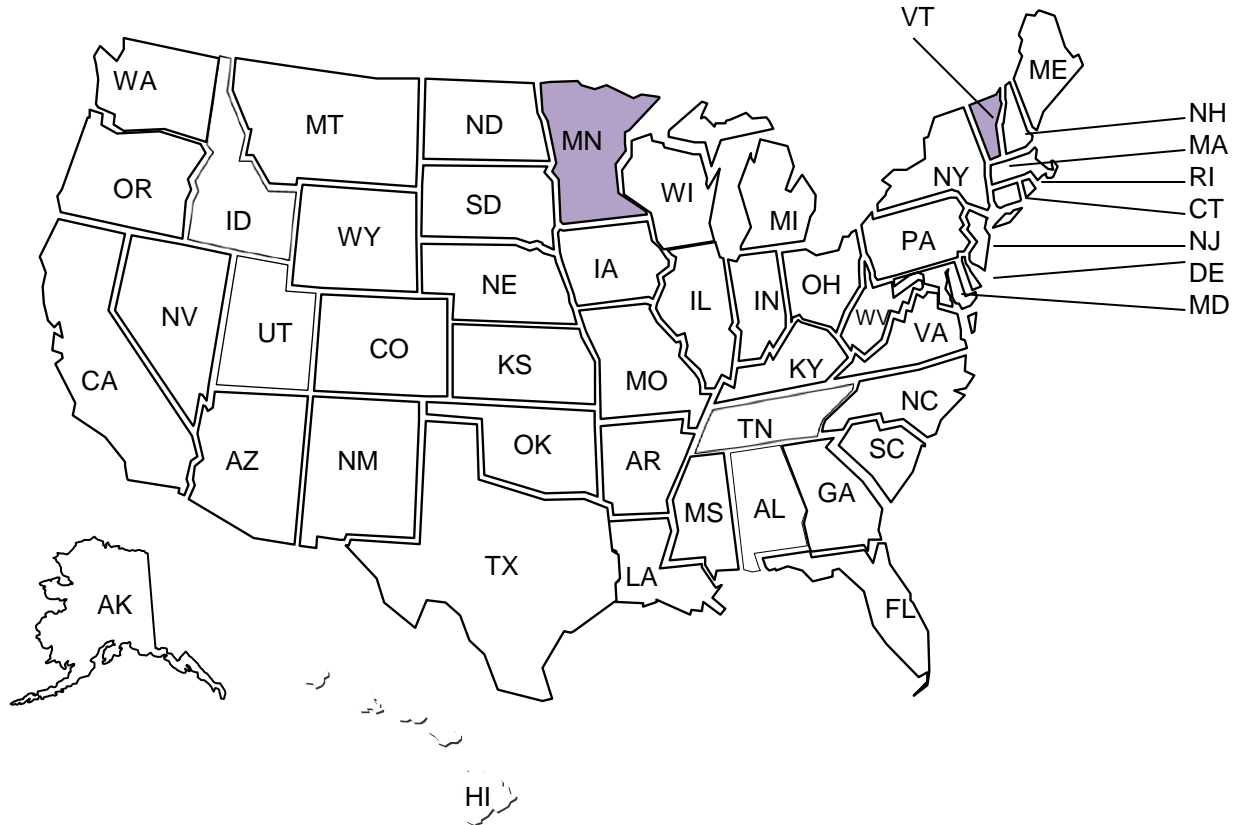
# States that Have Scheduled 5-MeO-DMT by Statute or Regulation

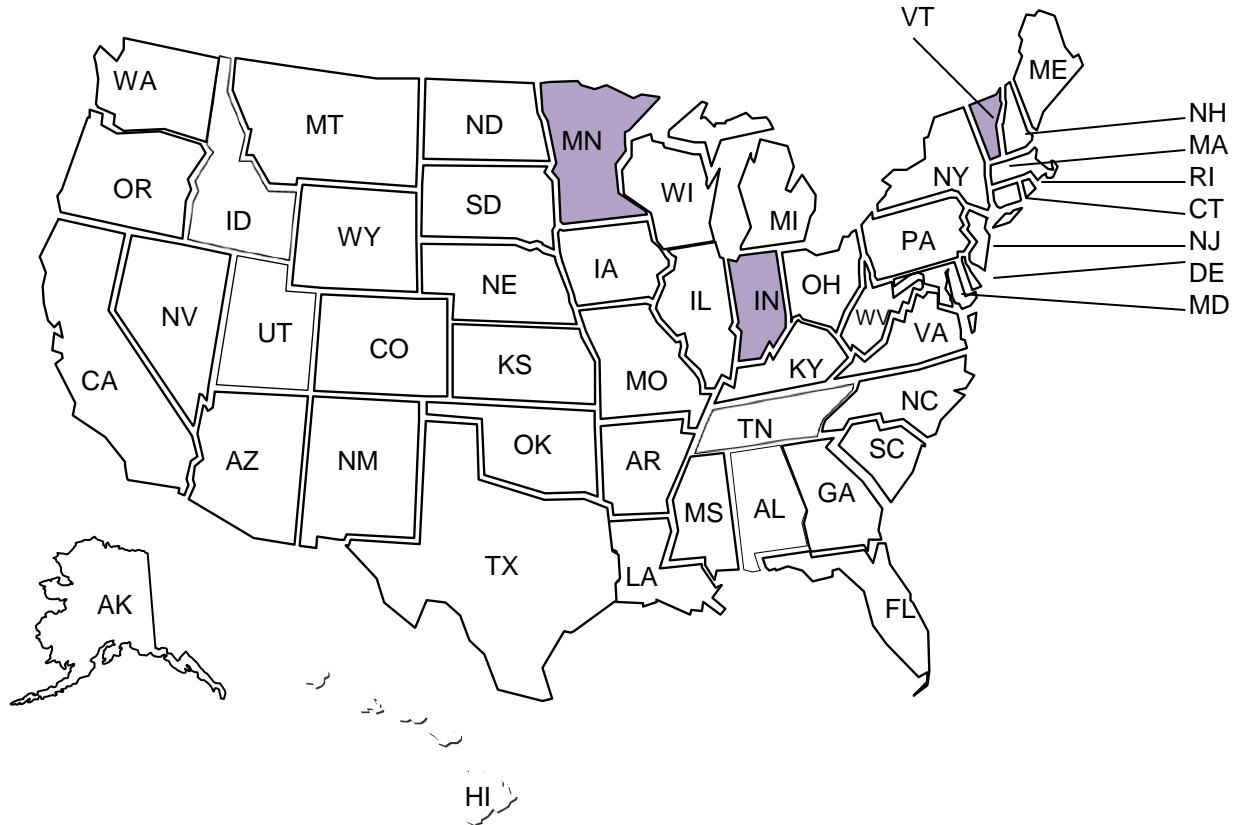
# States that Have Scheduled 5-MeO-MiPT by Statute or Regulation

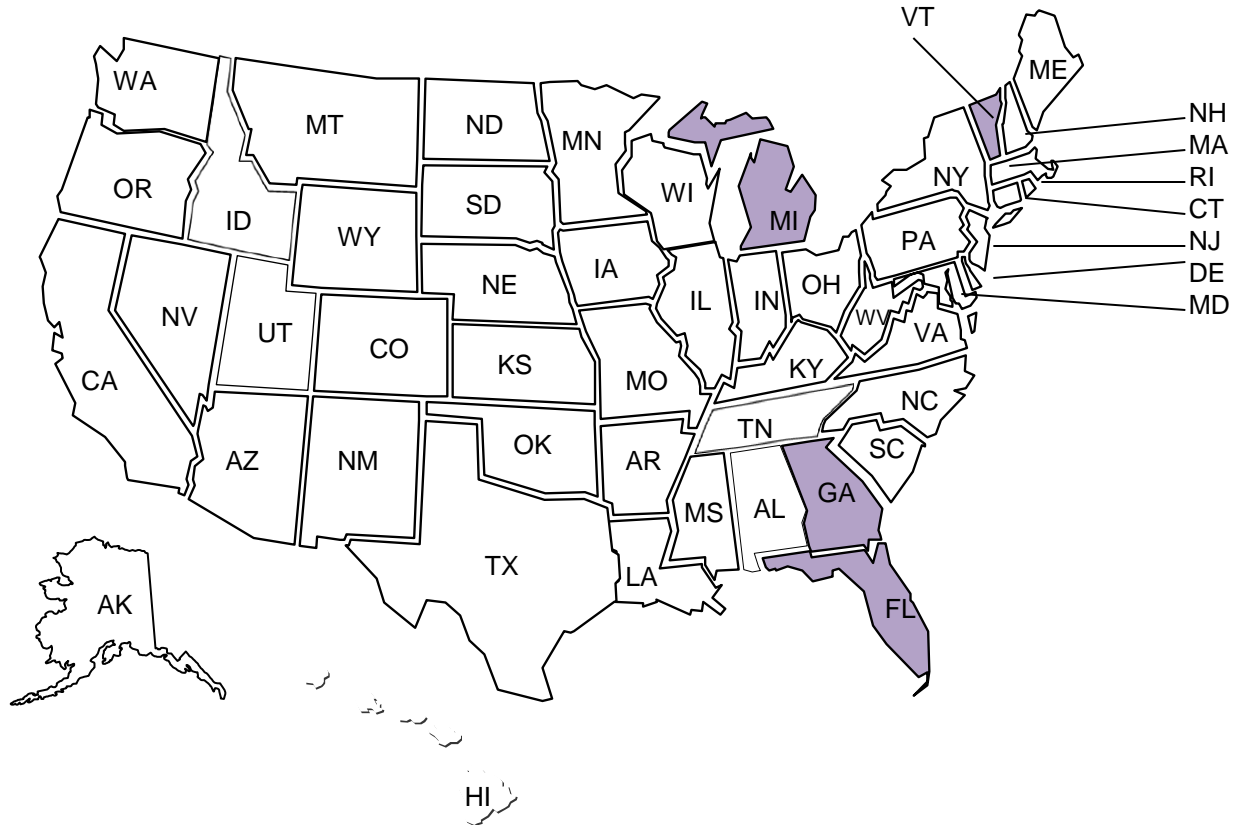
# States that Have Scheduled 6-APB by Statute or Regulation

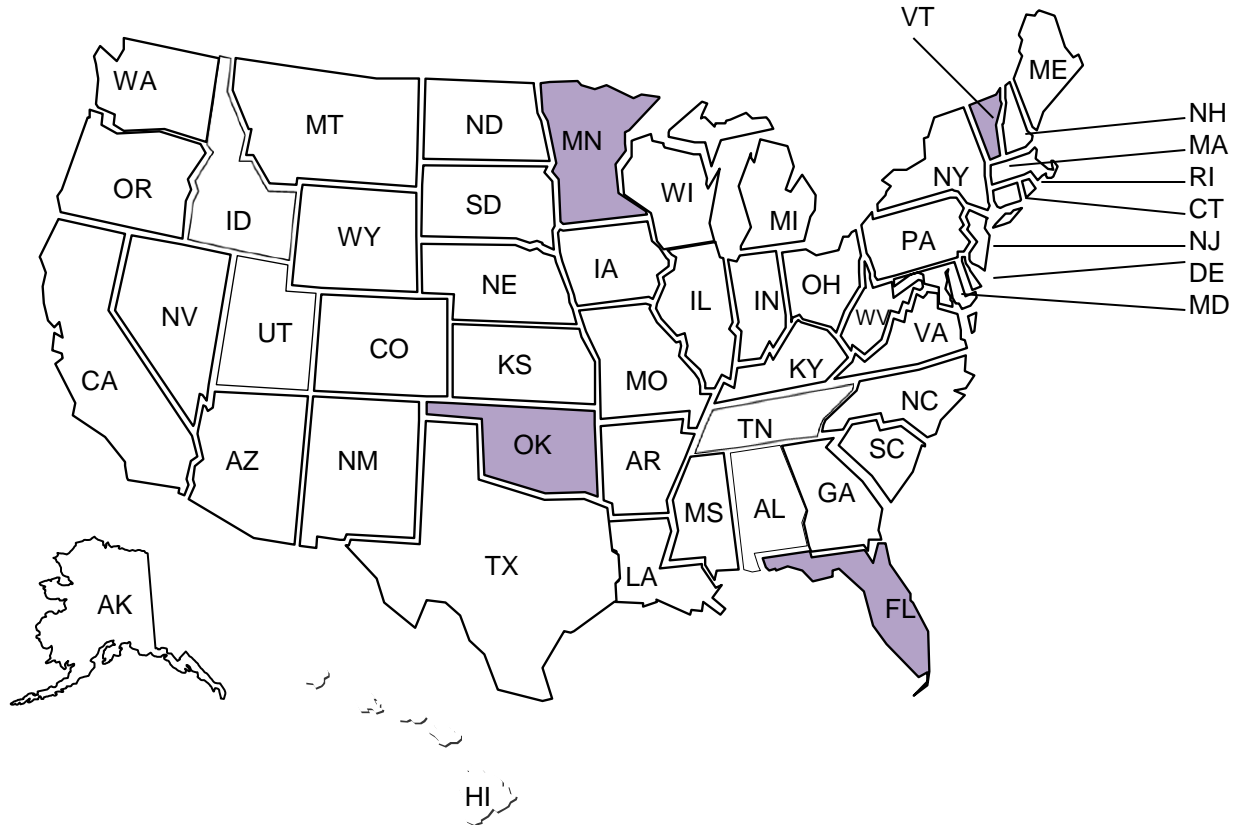
# States that Have Scheduled Chlorophenylpiperazine by Statute or Regulation

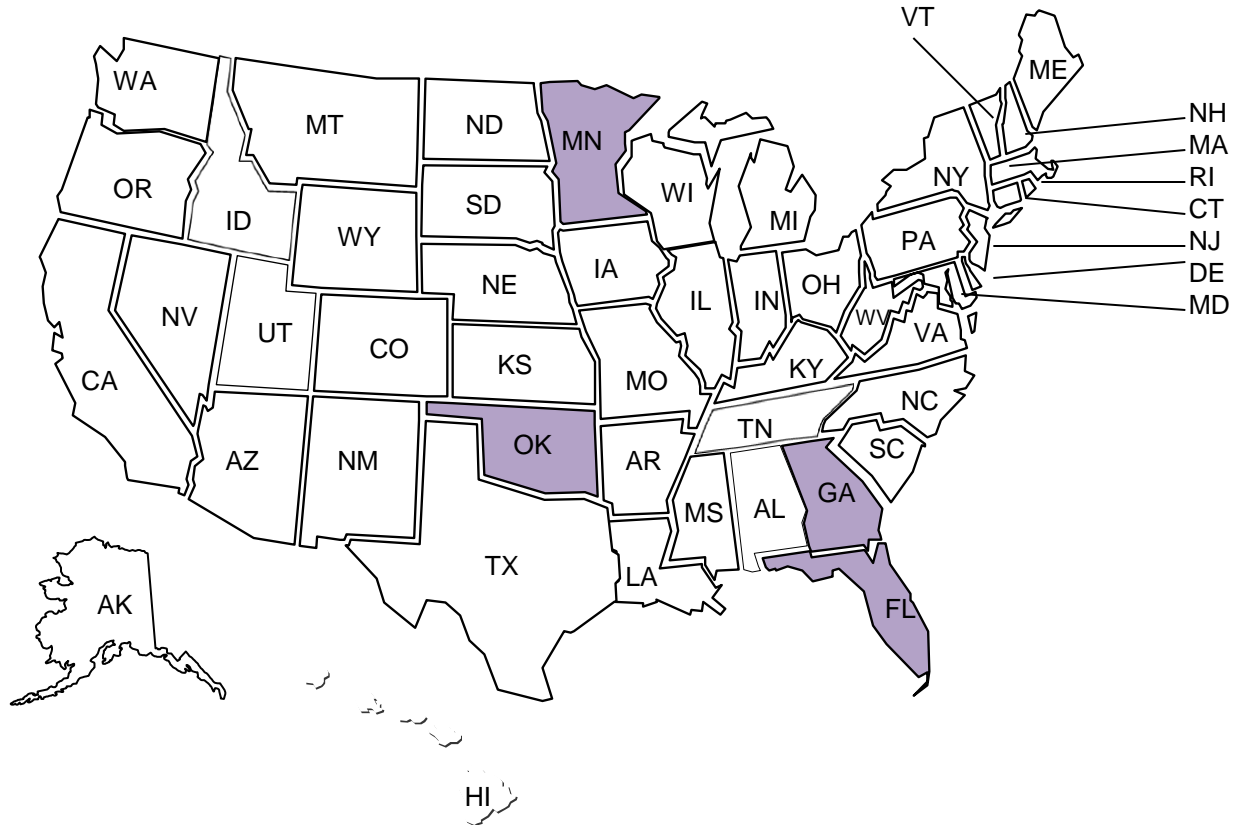

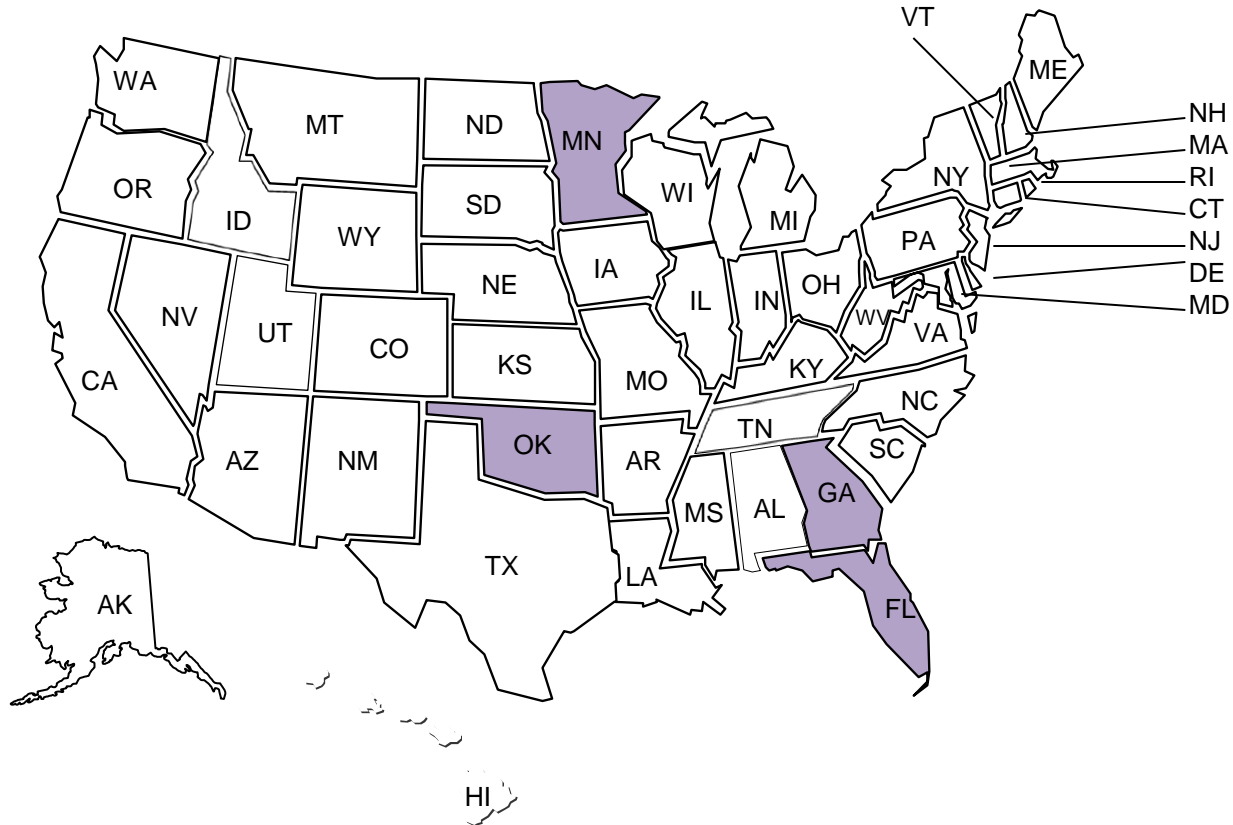

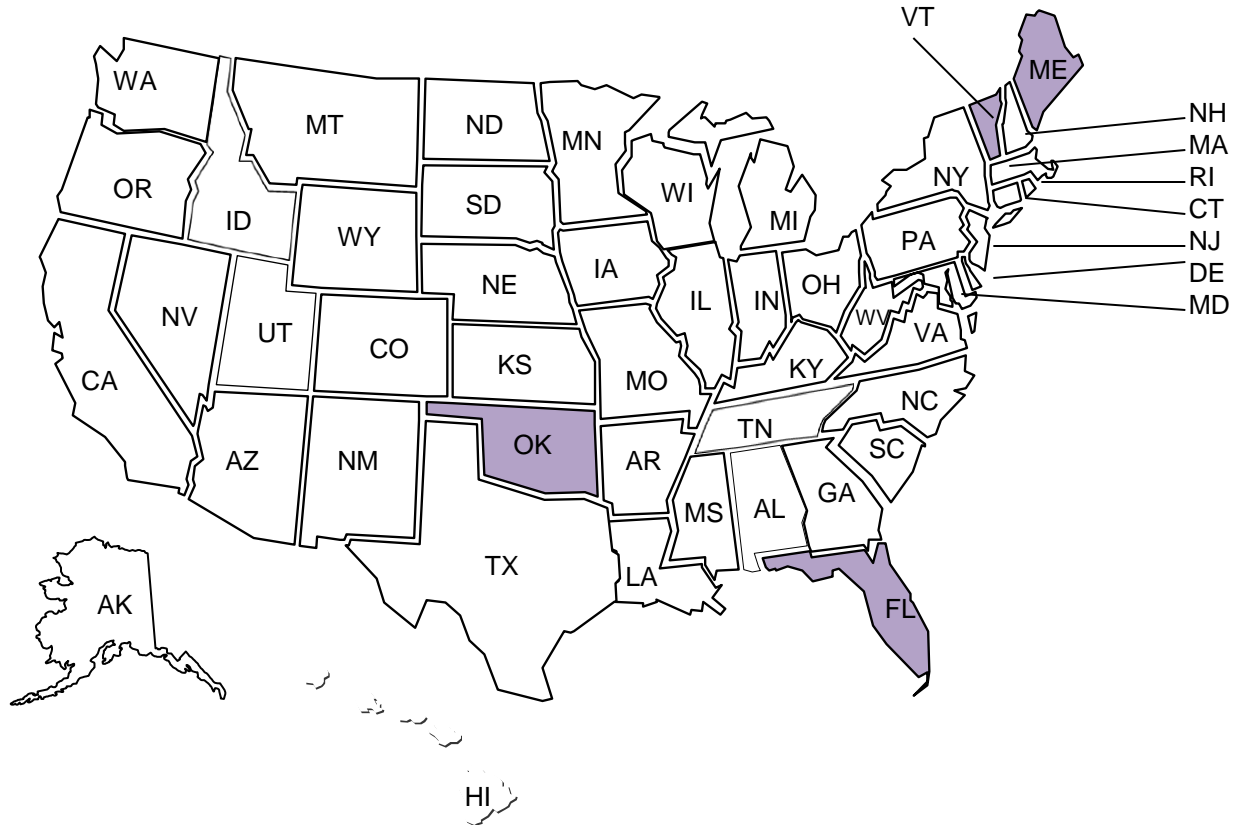

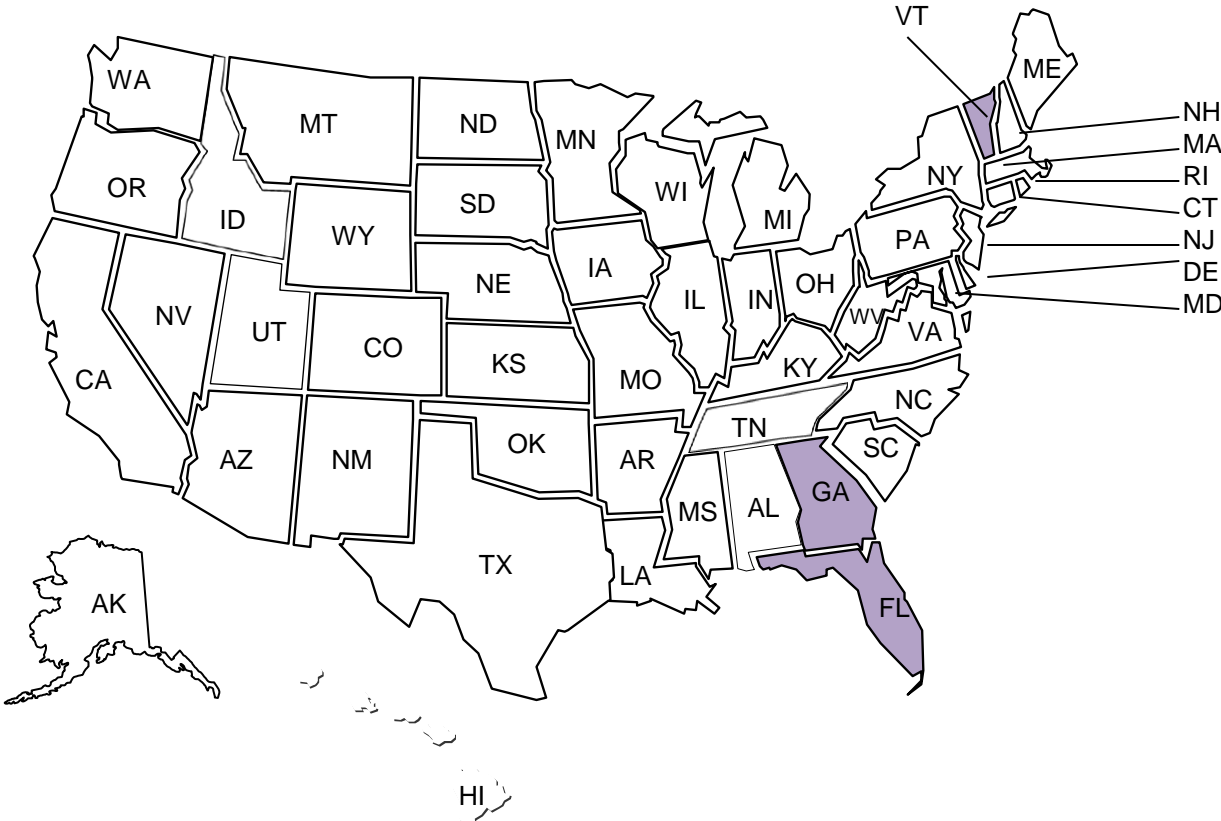
# States that Have Scheduled DPT by Statute or Regulation

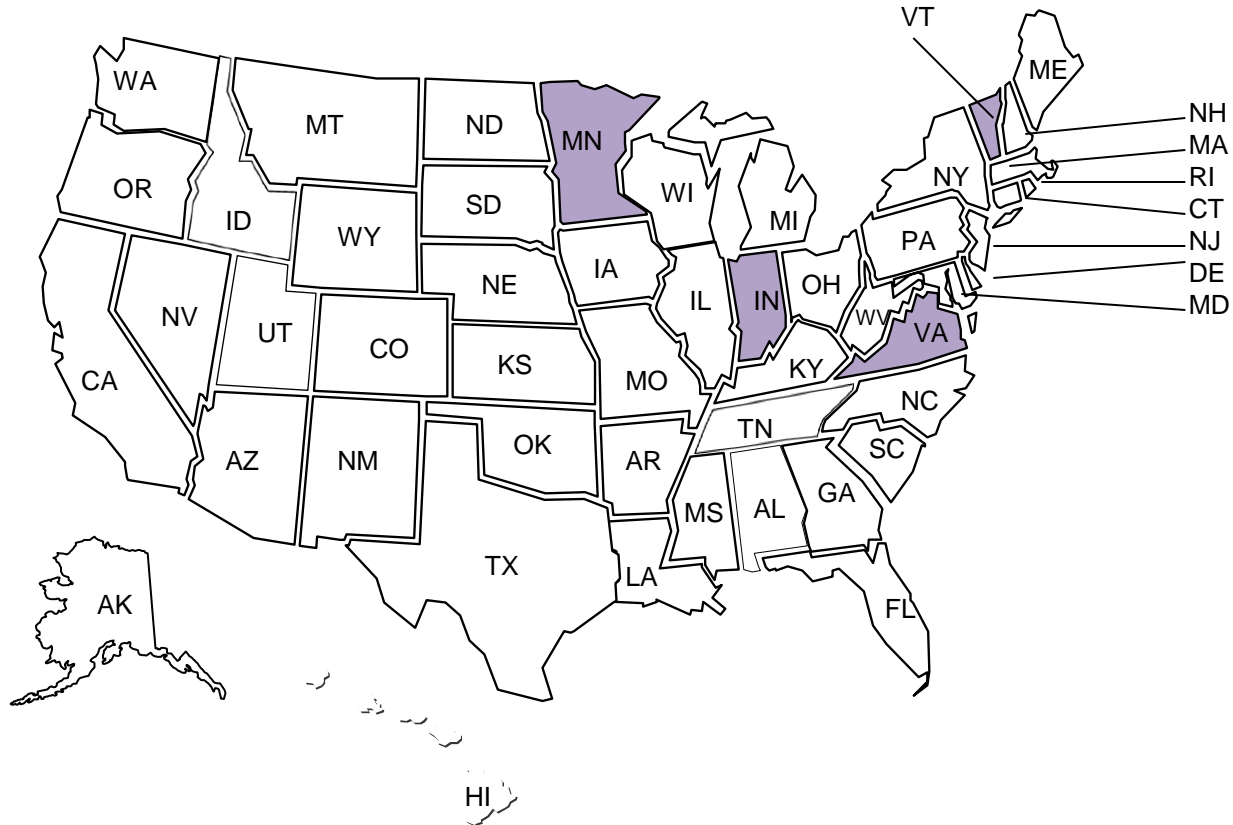
# States that Have Scheduled Fluorophenylpiperazine by Statute or Regulation

# States that Have Scheduled Methoxetamine by Statute or Regulation

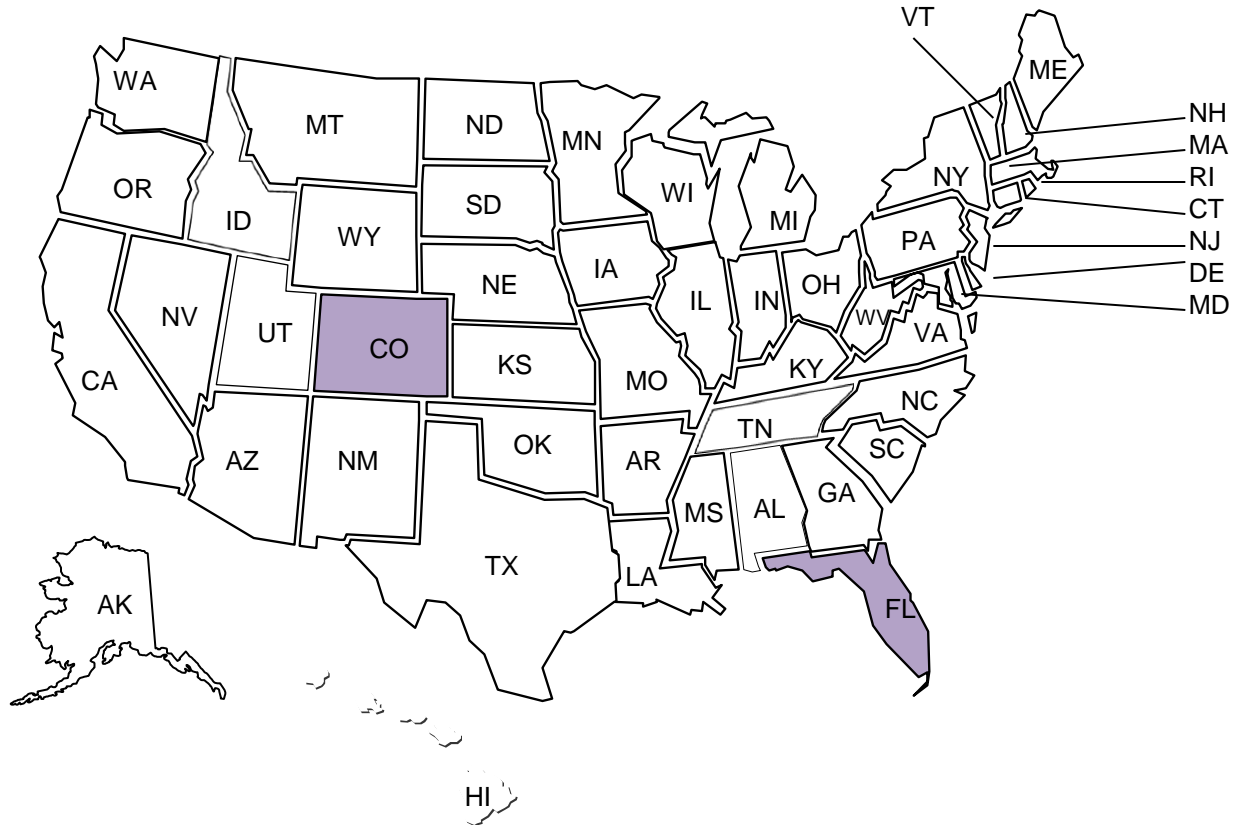

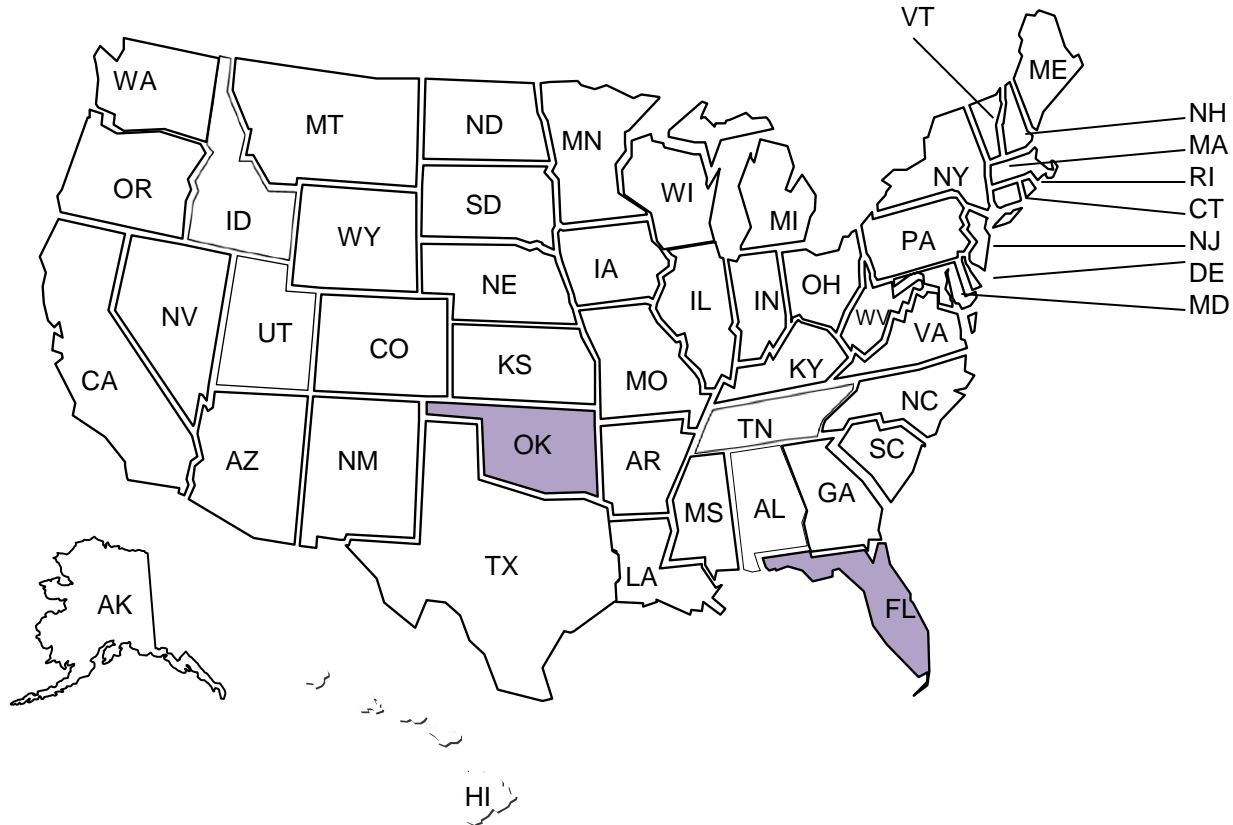
# States that Have Scheduled MPHP by Statute or Regulation

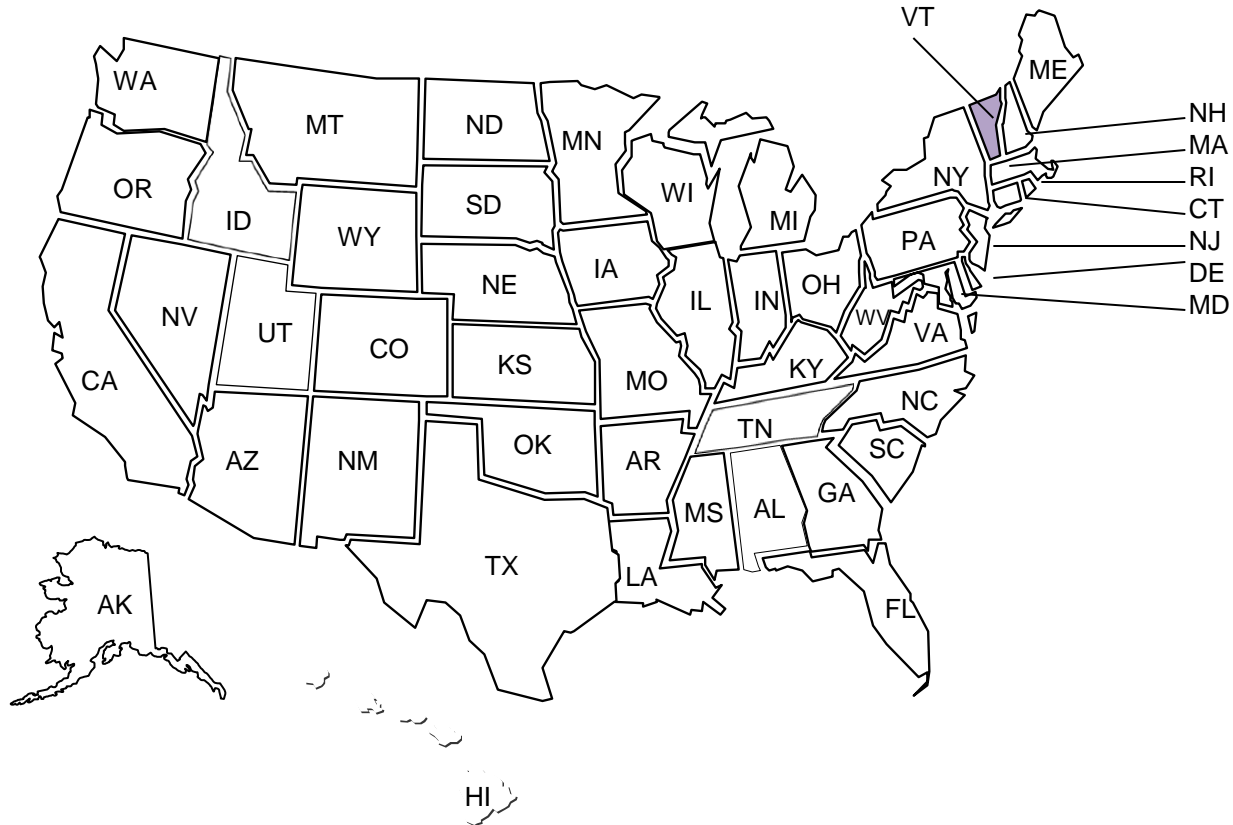

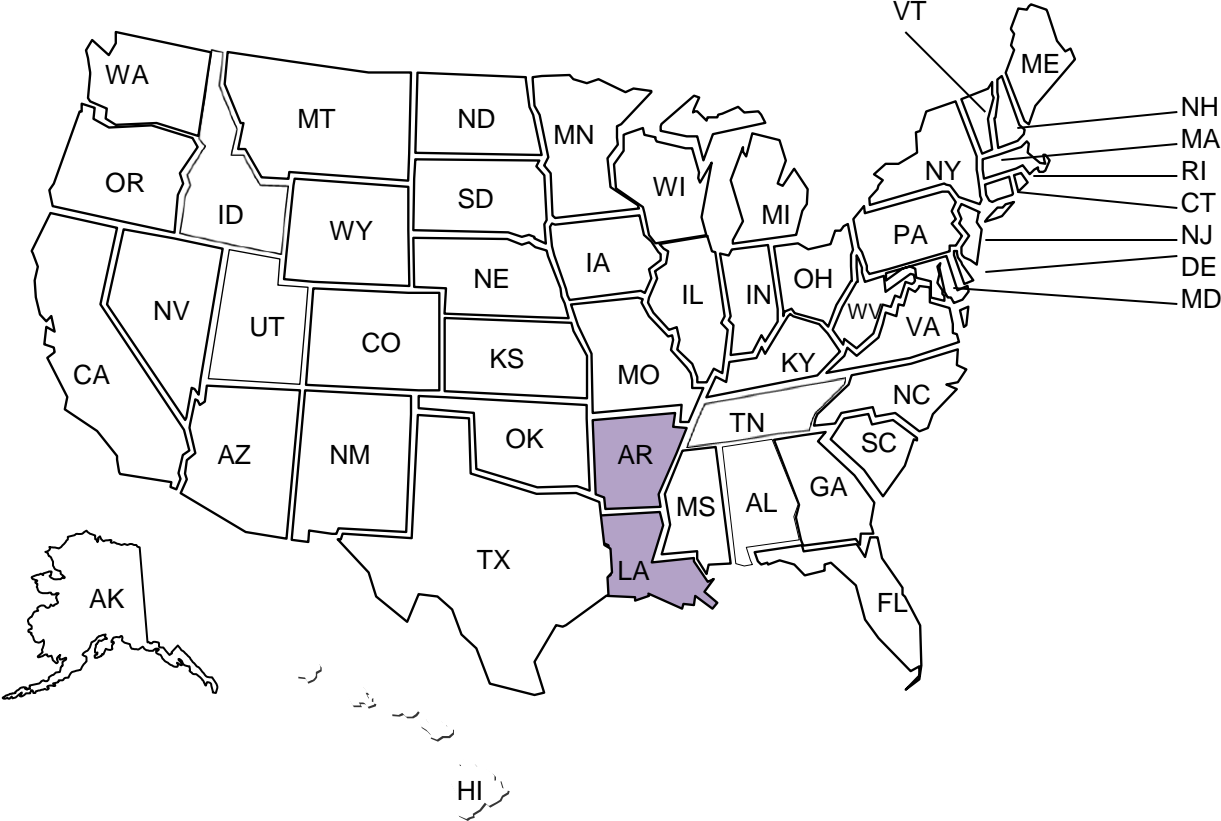
# States that Have Scheduled O-DT by Statute or Regulation

# States that Have Scheduled Phenazepam by Statute or Regulation

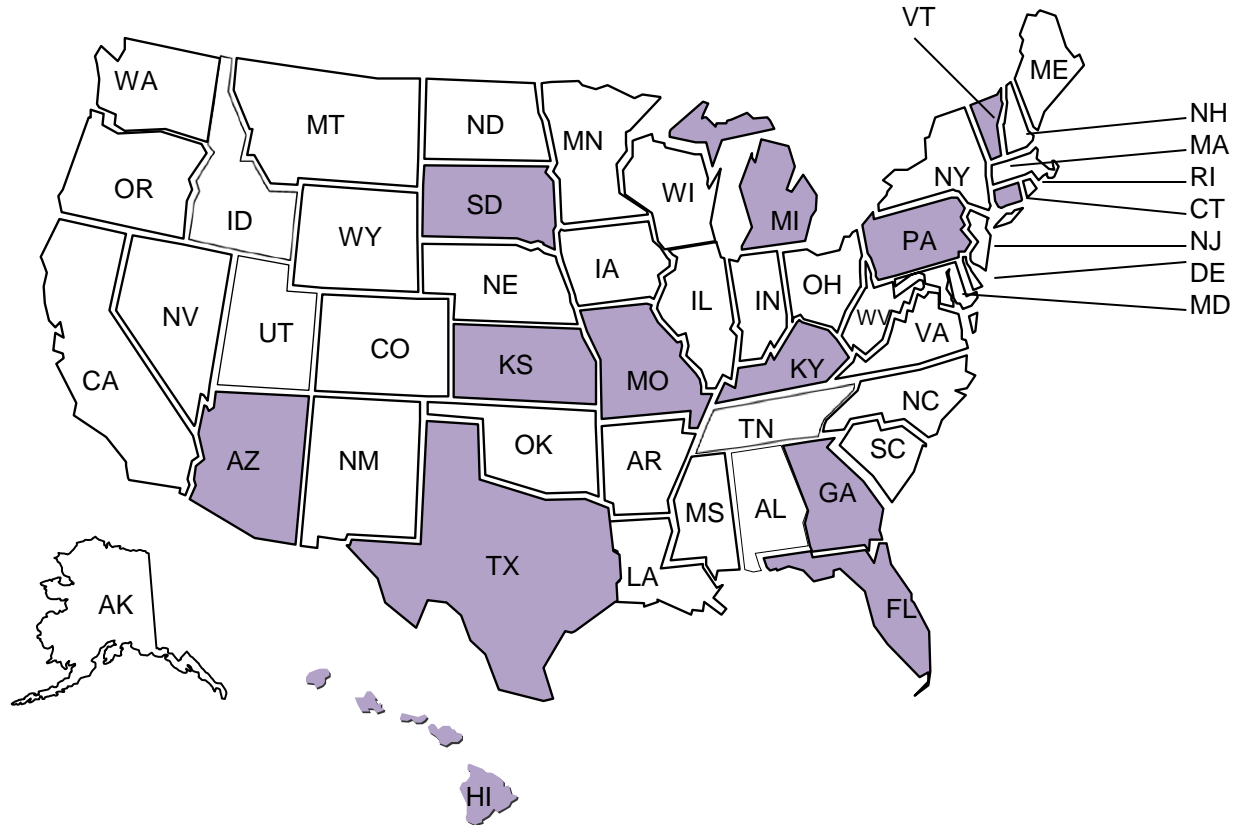
