<sup>1</sup> Maryland, Massachusetts, and New Hampshire have not scheduled synthetic cannabinoids by statute or regulation, but all three states incorporate the federal schedules by reference. Therefore, substances scheduled by the federal government are included as being banned by those states as well.

<sup>2</sup> In addition to those substances scheduled by statute or regulation in New Jersey, Ohio, and Oregon, those states also incorporate the federal schedules by reference. Substances included in the federal schedules are, therefore, included as being banned by those states as well.

<sup>3</sup> Please see the Trade Name and Chemical Compound chart for a full list of the miscellaneous JWH compounds. States indicated in this column have scheduled one or more of these compounds.
